



The Aggreko **SECURE** Fire, Theft, and Vandalism Protection Program (FTV) offers limited liability for the Aggreko equipment rented by you should you become a victim of such an unfortunate circumstance. For a very nominal fee, these worries will be eliminated from the overwhelming list of concerns you may already have regarding your temporary utility situation.

WAIVER

Aggreko has entered into an agreement with you to rent Aggreko's equipment (hereinafter referred to as the "Rental Agreement"). Under the terms of the Rental Agreement you are responsible for all loss or damage to the equipment, up to the replacement value. For the consideration and subject to the deductible stated below your responsibility for loss or damage to Aggreko's equipment due to fire, theft or vandalism ("FTV loss") shall be waived, provided all of the conditions set forth herein below have been satisfied.

You will immediately notify Aggreko upon your becoming aware of any loss or damage to the equipment, which knowledge will be presumed to have occurred within 48 hours of the occurrence giving rise to the loss or damage. You will be responsible for any additional or consequential damage resulting from your failure to timely notify Aggreko of the damage or loss. You will remain responsible for initial losses or damages to the equipment up to the lesser of the actual loss or damage or \$2,500 deductible ("Deductible") for each and every loss or damage, as well as the full extent of losses or damages occurring as a result of any circumstances set forth in the Waiver Exceptions.

WAIVER EXCEPTIONS

The FTV Program does not cover and you shall remain responsible for the following damages or losses:

- Any damage or loss caused, directly or indirectly, by your negligence or fault.
- Loss of equipment occurring when reasonable precautions have not been taken against theft or vandalism when you know or have reason to believe that the equipment will be located in an unsafe, exposed or non-secure location.
- Loss from any type of mysterious disappearance or shortage discovered in inventory.
- Use of the equipment in a manner inconsistent with the manufacturer's guidelines and instructions.
- Improper loading/unloading of the equipment or the unlawful transportation of the equipment, including any violation of traffic laws.
- Use of the equipment in hostile environments including but not limited to wars, riots, strikes and terrorist situations.
- Any damage to or loss to cable, duct and/or hose.
- The waiver will not apply if (i) prior to the commencement of the rental, you have not returned a duly executed copy of the acknowledgement page to the Aggreko proposal on which you have checked off the box accepting the terms and conditions of this FTV program; and (ii) each invoice issued under the Rental Agreement is not timely paid in full, including payment of the fees for your participation in this FTV program.

Except as otherwise stated herein, all other terms & conditions of the Rental Agreement remain in full force and effect.

The cost of the SECURE Program varies depending on the equipment rented. The fee is a set percentage of the rental charges on the unit or units covered as identified in the written quotation.
